BROAD GUIDELINES FOR WRITING OF THE OUTLINES OF THE RESEARCH PROPOSAL FOR A PH.D

- Research proposal of synopsis must be around 5000 words excluding Cover page, Bibliography, Table of Contents, Index, Abbreviations, etc.
- **Outline of Components of the research proposal :**
 - Statement of Research Problem
 - Significance of the topic
 - Objective of the study
 - Hypothesis
 - Methodology adopted by the researcher and its justification.
 - Review of literature
 - Research questions if any
 - Scope/limitation of the study
 - Tentative Chapterization
- **Format of preparation of Research proposal synopsis**
 - **Page:** A-4 size
 - **Font:** Times New Roman 12,
 - **Heading:** Times New Roman 14,
 - **Footnote:** Times New Roman 10
 - **Line and paragraph spacing:** 1.5 Inch
 - **Margin Left:** 1.5 Inch, rest of 1 Inch
- **Note:** - Keep checking your E-mail for periodical information.
