Greetings from MNLU-Aurangabad!

I am happy to present the second issue the University Newsletter "LAWRELS" which highlights the academic activities and the diverse achievements of the faculty and the students of the University.

Maharashtra National Law University, Aurangabad is a newly established university which came into existence on 16th March, 2017 under the Maharashtra National Law University Act, 2014. The University was formally inaugurated on 9th December, 2017 at the hands of Hon'ble Chief Minister, Shri. Devendra Fadnavis, who graciously accepted to be the Visiting Professor of our university.

The first academic session of our university commenced from 5th October, 2017. We made a modest beginning with 60 students in the first year of B.A.LL.B. (Hons.) course and we are soon going to commence LL.M. (Corporate and Commercial Laws) from the next academic session. Being a residential university, decent hostel facilities have been provided to the 1st year students at Kanchanwadi campus. Recently, the State government transferred the adjoining land of 9 acres to MNLU, Aurangabad on 8th Dec 2017. All efforts are being made to provide world-class infrastructure to make it an institution of national importance in this region.

The mandate and vision of the university is to advance and disseminate learning and knowledge of law and legal processes, and contributing to national development. Keeping this vision in mind, the university organised various activities for the students in its very first year. The University hosted its first National Seminar titled "Bhopal Gas Tragedy vis-a-vis Mass Torts" on 17th December, 2017. We were extremely honoured to have Padmashree Prof. Dr. N. R. Madhava Menon grace the occasion as the Guest of Honour. The University also organised an Inter-Disciplinary Discourse titled "Palliative and End of Life Care in India-The Road Ahead" on 3rd March, 2018. We had a series of Juridical Lectures delivered by legal luminaries like Dr. G. Narayana Raju, Hon'ble Mr. Justice S. V. Gangapurwala, Prof. (Dr.) V.K. Dixit, Prof. (Dr.) S.C. Shrivastava, Prof. (Dr.) Ghayur Alam, Prof. (Dr.) Durgambini Patel, Dr. Kondaiah, Dr. P. Sukumaran and Shri. Yashodeep Deshmukh on several topics of legal importance.

The commencement of the University would have been impossible without the able guidance of the Chancellor, Hon'ble Mr. Justice Ranjan Gogoi, Judge, Supreme Court of India. Hon'ble Mr. Justice Ranjan Gogoi Chancellor, MNLU-Aurangabad

Hon'ble Mr. Justice Ranjan Gogoi was born on 18th November, 1954. He joined the Bar in 1978 and practised mainly in the Guwahati High Court. He was elevated as a Permanent Judge of Guwahati High Court on 28th February, 2001. He was transferred to Punjab & Haryana High Court on 9th September, 2010. He was appointed as Chief Justice of Punjab & Haryana High Court on 12th February, 2011 and the Judge of the Supreme Court on 23rd April, 2012.

Hon'ble Mr.Justice Ranjan Gogoi, a great idealist who expanded the horizons of legal arena and made giant strides in various cases eyed the essence of justice and law in the society and put forward his vision in the form of the foundation of the Maharashtra National Law University, Aurangabad.

We are greatly honoured to have his constant support and guidance as the Chancellor of the university.



Hon'ble Mr. Justice N.V. Ramana

Judge, Supreme Court of India

Justice N.V. Ramana is the member of General Council of the university. He has practiced in the High Court of Andhra Pradesh, Central and Andhra Pradesh Administrative Tribunals and the Supreme Court of India in Civil, Criminal, Constitutional, Labour, Service and Election matters. He has specialized in Constitutional, Criminal, Service and Inter-State River laws. He has also functioned as Panel Counsel for various Government Organizations. He has functioned as Additional Standing Counsel for Central Government and Standing Counsel for Railways in the Central Administrative Tribunal at Hyderabad. He has also functioned as Additional Advocate General of Andhra Pradesh. He was appointed as a permanent Judge of the Andhra Pradesh High Court on June 27, 2000. He functioned as Acting Chief Justice of Andhra Pradesh High Court from March 10, 2013 to May 20, 2013. He had participated in several National and International Conferences held in India and aboard and submitted papers on various topics of legal importance. He was elevated as the Chief Justice of Delhi High Court September 2, 2013 and further as a Judge of Supreme Court of India February 2, 2014.

Hon'ble Mr. Justice N.V. Ramana enkindled an awakening in the legal stage through leaps and bounds. He is one of the main persons responsible for igniting the torch of legal education by laying down the groundwork of this prestigious university. He is the Judge of the common man, who is socially conscious and sensitive to the issues of the society.

Events

Inaugural Function

The University was formally inaugurated at the hands of Hon'ble Chief Minister, Shri. Devendra Fadnavis in a function organised on 9th Dec. 2017 in the residential campus. Eminent personalities like Justice Smt. V.K. Tahilramani, Acting Chief Justice of Bombay High Court, Shri. Haribhau Bagade, Speaker, Maharashtra Legislative Assembly, Justice Shri. R.M. Borde, Judge, Bombay High Court Bench at Aurangabad and Justice Shri. S.V. Gangapurwala graced the occasion.



Hon'ble Vice-Chancellor, Prof. (Dr.) S. Surya Prakash delivered the welcome address and invited Hon'ble Shri. Devendra Fadnavis to be Honorary Professor of the university. He also assured the Chief Minister that, "If you provide the infrastructure within two years, I will give you an institution of excellence in Aurangabad."

CM Devendra Fadnavis termed this day as historic and thanked Hon'ble Supreme Court and Hon'ble Bombay High Court for all the cooperation they extended for setting up of Maharashtra National Law University at Aurangabad, one of the 3 NLUs in State. We have the responsibility to give land and provide other infrastructure for all these institutes. Our objective is to make all these institutions of international repute so that our students need not go to other States. He appealed the students to keep themselves updated with knowledge of modern technology. He said that our Universities should focus more on research. The State Government has been working extensively to make all facilities available in Marathwada & Vidarbha region with many projects in almost all sectors, for speedy development. He added that all these projects would be completed in 2-3 years.

Hon'ble Mr. Justice R.M. Borde delivered the presidential address. He said that the establishment of Maharashtra National Law University at Aurangabad is a landmark in the educational development of the region and acknowledged the support extended by the State Government in commissioning the Law University within a record period of seven months from the date of appointment of the Vice-Chancellor. He further appealed the State Government to allot land required for the university and to provide necessary financial assistance. He assured to extend full support to the university on behalf of the Judiciary.





Hon'ble Justice Smt. V.K. Tahilramani, who graced the function as the Guest of Honour, also spoke on the occasion. She appreciated the efforts made by the Government for translating the dream of creating National Law University at Aurangabad into a reality. She also quoted some famous lines by great personalities and said that a student of Law University must learn the mechanics of law and the constitutional mandate in such a fashion that it would give true meaning to ideas of the makers of our Constitution and help to bring them in reality.

The Chief Minister, Hon'ble Shri. Devendra Fadnavis released the very first issue of the University newsletter "LAWRELS" on the occasion, which was completed in a very short span of time. Prof. V.R.C. Krishnaiah, Registrar Incharge proposed a vote of thanks and the programme concluded with the national anthem.

औरंगाबाद : सहा महिन्यांपूर्वी स्थापन झालेल्या महाराष्ट्र राष्ट्रीय विधि विद्यापीठ, औरंगाबादला आगामी दोन वर्षात जिमनीसह सर्व प्रकारच्या पायाभूत सेवा-सुविधा उपलब्ध करून देणार असल्याची घोषणा मुख्यमंत्री देवेंद्र फडणवीस यांनी केली.

Interdisciplinary Discourse

Maharashtra National Law University, Aurangabad in collaboration with End of Life Care in India Task Force (ELCIT) organized an Interdisciplinary Discourse on "Palliative and End of Life Care in India-The Road Ahead" on the 3rd of March 2018. Resource persons from the medical field, judges, advocates and academicians shared their views and their practical experience on the theme. The event was graced by the presence of distinguished guests from various fields.

Right to Life along with the right to lead a dignified life is a basic human right of an individual that has been recognised in various national and international documents, including the Constitution of India. Seldom there has been any concern about the right of those individuals who are having least hope to lead a healthy life owing to their severe and fatal infirmities. This discourse focused on the concepts of Palliative Care and the right to live a dignified life.





The event started with the lighting of the lamp and felicitation of the resource persons by Hon'ble Vice Chancellor Prof.(Dr.) S. Surya Prakash. It was followed by the address of Hon'ble VC Prof (Dr.) S. Surya Prakash. Hon'ble Justice Shri R.M Borde, Judge, High Court of Bombay, Bench at Aurangabad was the Chief Guest of the event. Dr. Roop Gursahani-Neurology Consultant, Hinduja Hospital; Dr. Nagesh Simha- President, Indian Association Of Palliative Care; Prof. Mukesh Srivastava- Acting Director, NLIU Bhopal were the Guests of Honour. The event was presided by Prof. (Dr.) S. Surya Prakash- Vice Chancellor, MNLU-Auranagabad and mentored by Prof. (Dr.) V.R.C. Krishnaiah- Registrar I/C, MNLU-Aurangabad. Prof. V.K. Dixit and Adv. Girish Gokhale were also a part of this event.

The event witnessed presentations by students who discussed their research papers in detail centred around the theme of Palliative and End of Life Care. Mr. Ashok Wadje, Assistant Professor of Law, MNLU-Aurangabad presented his views on "the Constitutional Perspective of Santhara", a religious practice among people following Jainism where they fast till death, gradually reducing the intake of food and liquids. Ms. Mahenaz Haque, Assistant Professor of English, reviewed the book "Being Mortal" authored by Atul Gawande which revolves around the very concept of Palliative and End of Life Care. The event came to an end with the Aurangabad Declaration on Palliative and End of Life Care in India.

Juridical Lectures

As a part of the academic programme, the university organised a series of juridical lectures so that our 1st year students of B.A.LL.B. (Hons.) get an opportunity to interact with distinguished legal luminaries and update their knowledge through such discourse. 

Late Mr. Justice V.S. Deshpande Reading Room



Late Mr. Justice Venkat Shrinivas Deshpande assumed charge as Acting Chief Justice of Bombay High Court on 19th November, 1980 after Hon'ble Justice B.N. Deshmukh. He was appointed as Chief Justice on 12th January 1981.

Justice V.S. Deshpande was born on 11th August, 1920. He was educated at Yogeshwari Nutan Vidyalaya High School, Ambejogai, Osmania University Law College, Hyderabad. He enrolled as First Grade Pleader of the former High Court of Hyderabad in October, 1945 and was permitted to appear in the High Court as per rules of the said High Court with effect from April 1947. He enrolled as an Advocate at the Hyderabad High Court in October, 1952, after the Bar Council Act of 1926 was

made applicable to the Hyderabad State. In the year 1957 enrolled again as an advocate at the Bombay High Court as per provisions of the States Regulation Act, 1956. He did Criminal and Civil work of Original Side while practising in Hyderabad Court from 1945 to 1956 and Civil and Criminal work at the Appellate Side in Bombay High Court since 1957. He worked as Assistant Government Pleader in Bombay High Court from March 1961. He was appointed as Additional Judge of the Bombay High Court on 11th June, 1967 and was made a Permanent Judge on 8th January,1968. He was appointed Acting Chief Justice from 19th October, 1980. He retired as Chief Justice of High Court of Bombay on 11th August, 1982.

We are deeply indebted to Hon'ble Justice A.B. Naik, Former Judge, High Court of Bombay Bench at Aurangabad for his magnanimity to have generously donated his personal library to the university in memory of his beloved father in law, Late Mr. Justice V.S. Deshpande, which enabled us to set up a reading room for our students at Kanchanwadi Residential Campus.








