- CRITERIA FOR REGISTRATION:** Those Candidates who have appeared for Common Law Admission Test-2023 (CLAT-2023) conducted by Consortium of National Law Universities, **are eligible to Register** for the provisional admission as per the above-mentioned matrix of vacancy of seats in the prescribed registration form.
- REGISTRATION FORM:** Candidates should make an Application (Registration) only in the prescribed form i.e., Google Forms (**Link to the Google Form is: <https://forms.gle/u3Y7wQZDvKhncVBq6>**). Any other format of Application will not be entertained.
- EMAIL ID FOR REGISTRATION:** Candidates are hereby informed to use personal e-mail ID for the purpose of Registration and should use the same e-mail ID for all purposes till entire admission process and further communication with respect to Admission or Cancellation of Admission or Refund of Admission Fee.
- REGISTRATION FEE:** Registration Fee (Processing Fee) for the Vacant seats is **Rs.1000/-** in case of General & Other Categories and **Rs.500/-** in case of SC and ST Category, to be paid through the following link <https://forms.edugfix.com/institutionalrr/add> Candidates have to attach a receipt of payment of Registration Fee in the Google Form mentioned above. (**Note:** Registration Fee is not refundable)
- RESERVATION:** For Reserved category seats only candidates from State of Maharashtra are eligible for apply according to the rules in force of State of Maharashtra.

6. **HORIZONTAL RESERVATIONS** for the candidates belonging to Women, Children of Defence Service Personnel, and Specially Abled Persons / Person with Disability shall be followed according to the rules in force of State of Maharashtra.
7. **SUBMISSION OF DOCUMENTS:** Application form must be complete in its entirety. The Candidate should upload / attach all mandatory documents with relevant copies as mentioned in the “*List of Documents*” (for UG & PG) provided on the Website of the University under the Admission Tab. (Click here: <https://www.mnlua.ac.in/clat-2023-notification>)
IF ANY CANDIDATE FAILS TO UPLOAD ANY MANDATORY, RELEVANT AND REQUIRED DOCUMENT IN THE ONLINE APPLICATION FORM, THE UNIVERSITY SHALL NOT CONSIDER THE REGISTRATION / APPLICATION FORM FOR THE ADMISSION AGAINST THIS NOTIFICATION.
8. **SELECTION OF CANDIDATES:** Selection of Candidates against the vacant seats will be done on the parameter of **CLAT score** as received in **CLAT examination** in the respective Category. Candidates will be considered for admission against reserved categories if they have applied for the same in the CLAT application form. After the preparation of merit list, the selected candidates will be called for personal interview (through online mode).

Candidates will be assessed on following Parameters:

- 40.00% weightage – CLAT Score
- 20.00% weightage – Performance in 10th Standard
- 20.00% weightage – Performance in 12th Standard
- 20.00% weightage – Performance in Personal Interview

Thereafter, only the Candidates Selected through Personal Interview will be called for document verification and provided provisional admission to the university.

THE UNIVERSITY RESERVES THE RIGHT TO ADMIT STUDENTS.

9. **DEADLINE FOR REGISTRATION:** The last date for the submission of Registration / Application Form (Google Form) shall be **Tuesday, June 27, 2023 on or before 10:00 PM.**
10. **LIST OF SELECTED CANDIDATES:** List of the selected Candidates will be displayed on the website of the University (under Admission tab) on June 28, 2023 by 10:00 PM.

11. **PAYMENT OF ADMISSION FEE:** The selected candidates should pay the Admission Fee of the University as per the details given on the website of the University. **After publication of the list of selected Candidates, the Candidates shall have to deposit the Fee of the University and send the receipt of the Admission Fees to admissions2023@mnlua.ac.in , aao@mnlua.ac.in and mark CC to fao@mnlua.ac.in.**
12. **RIGHT TO FILL THE VACANT SEATS:** The University shall have right to fill up any additional vacancy, if any, that may arise in future. Further, the university reserves the right with respect to admission of students through institutional round.
