About the Event:

The year 2023, marks the Golden Jubilee Celebrations of the historic Kesavananda Bharati Judgment which evolved the 'Doctrine of Basic Structure', as a foundation of Constitutionalism and Constitutional Governance.

This landmark judgment is a turning point in upholding Constitutional Supremacy and maintaining a delicate balance of separation of power of the largest Constitutional Democracy in the world. This judgment has great relevance from the perspective of constitutional interpretation even after 50 years of the judgment and is a subject matter of academic research and debate for judges, academicians, professionals, and scholars.

The University has scheduled to observe a week of celebration of the historic Kesavananda Bharati on 50 Years of its judgment, through its Constitution Law Club under the aegis of the Centre for Constitutional Law and Governance (CCLG) from 14th – 18th March, 2023.



About the CLC (Constitutional Law Club), MNLUA:

4. To watch the working of the Constitutional Courts and analyze the development critically.
5. To conduct research from a comparative perspective in order to analyze the position of the Indian Constitution and governance in a better way.

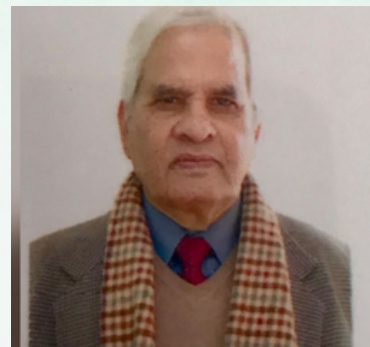

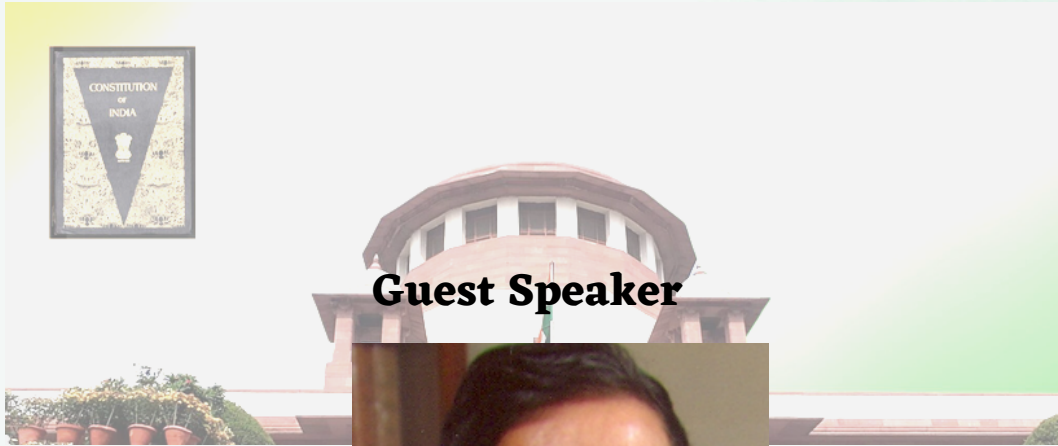
