## **NOTIFICATION FOR VACANT SEATS**

Maharashtra National Law University, Aurangabad invites applications against vacant seats for B.A.LL.B. (Hons.) Five Years Integrated Degree Course for the Academic Year 2019-20. Those candidates who fulfil eligibility criteria as per CLAT-2019 are only eligible to apply.

- 1) Interested candidates are required to apply only in the prescribed application form. *(See page 3).*
- 2) Admission against vacant seats will be done as per the Merit List prepared on the basis of CLAT Rank of the applicants.
- 3) The duly filled-in application form is to be scanned and sent to [admission@mnlua.ac.in](mailto:admission@mnlua.ac.in) through email along with the scanned copy of enclosures, i.e. caste certificate and validity (if applicable), CLAT Admit Card, CLAT Score Card and **application fee receipt (Rs.1,000/- for General and Rs.500/- for SC/ST category)**, failing which the application form will not be accepted. *(For Account details see page 2)*
- 4) The duly filled-in scanned application form along with the enclosures must be sent on or before 11<sup>th</sup> July 2019 by 4:00 P.M.
- 5) Applications / requests received before the date of this notification i.e. 05/07/2019 and after the last date i.e. 11/07/2019 by 4:00 P.M. will not be considered for preparation of Merit list.
- 6) The Merit list will be notified on the website of the University on 12/07/2019 after 04:00 P.M.
- 7) The candidates whose name appears in the provisional merit lists will be required to pay Rs.50,000/- as Counselling Fee on or before 16<sup>th</sup> July 2019 by 4:00 P.M.
- 8) The **Counselling Fee of Rs. 50,000/- is non-refundable**, if the candidate fails to report for Spot Admission on notified date or fails to produce the necessary documents required for admission. In such case, Counselling Fee of Rs. 50,000/- shall be forfeited and the seat will be allotted to the next candidate in the order of merit list.
- 9) If the candidate (whose name appears in the merit list) fails to transfer the Counselling fee of Rs. 50,000/- within the stipulated time, then his / her candidature will be dropped from the Merit list.
- 10) Candidates will be required to pay the full fee at Maharashtra National Law University Aurangabad at the time of reporting on the day of Spot Admission for vacant seats.
