1. **Provisionally admitted candidates** will be contacted by the University for further process and commencement of the Classes on the e-mail ID registered with the University during admission.
2. **Selected Candidates** are hereby informed to pay the Admission Fees of the University on or before **THURSDAY, OCTOBER 14, 2021**. After that the payments will not be accepted by the University.
3. The receipt of the payment must be sent on the e-mail ID: nikalje.akshay@mnlua.ac.in and mark "CC" (copy) to e-mail ID: fao@mnlua.ac.in
4. Admission Fee of the University can be seen on the website of the University and Admission Fee must be deposited in the Bank Account of the University (Click here to know more: <https://www.mnlua.ac.in/Download/Fee%20Structure%20and%20Bank%20Details-2021-2022@23821.pdf>)
5. Admission of the selected Candidates shall be confirmed only after payment of the University Fee, failing which the Seat shall go to the next Candidate in the waiting list.
6. Selected Candidates are hereby informed that your Admission after payment of University Fee will be provisional in nature. The same will be confirmed only after submission of all required and relevant documents given on the website in person and in original form to the University.
7. Admission of the selected candidates will be confirmed only after verification of both: **a) Admission Fee** and **b) required documents**.
