## **About Maharashtra National Law University, Aurangabad**

The State of Maharashtra realizing the importance of quality Legal Education and need for well-trained Law Graduates in the Bar and Bench took a decision to establish three National Law Universities in the State of Maharashtra at Mumbai, Nagpur and Aurangabad in the years 2015, 2016 and 2017 respectively to cater the needs of quality legal education. All three National Law Universities are independent and autonomous in nature and are established by virtue of the Maharashtra National Law University Act, 2014. The Maharashtra National Law University, Aurangabad commenced its operation from March 16, 2017. The Maharashtra National Law University, Aurangabad being an institution of national importance has fulfilled the aspirations of the people of the Marathwada Region. The University has 50 acres of lush green campus at Kanchanwadi, Chhatrapati Sambhajinagar (Aurangabad).

**Note: This is a self-financed Course. The University follows the State Government of Maharashtra's reservation policy for admitting students. However, the State Government of Maharashtra scholarships is not available for the students of the course. The students have to bear the entire fees of the Course.**

### **Two Years MBA Programme (Financial Services and Court Administration)**

Financial sector comprised of commercial banks, non-banking financial companies, insurance companies, mutual funds, co-operatives, pension funds along with brokerage firms which deal in financial market. The sector is witnessing strong and accelerated growth. With various reforms government has liberalized the industry. Indian financial sector is making significant contributions to the world economy.

Financial services industry is governed by strict rules and regulations to make it fair and beneficial for investors.

A blend of Law and Management education is necessary for critical decision making in a dynamic and volatile business environment within the permissible limit of legal system. The understanding of business of financial services firms as well as Law is required for efficient functioning of the system.

MBA in Financial Services, students will develop an analytical approach to the intricacies of finance and business, be able to seize the digital opportunity and learn to manage risk and drive profitability in the rapidly transforming financial services institutions.

Furthermore, there is huge demand of such professionals who have understanding of Finance as well as have command on court management. There is scarcity of institutions offering court management skills. The MBA Programme (Financial Services and Court Administration) will inculcate all the necessary skills in students with which they can perform efficiently in both at corporate as well as at administration of court.

## **Admission Process**

### **a. Eligibility**

Bachelor's degree from a recognised institution in any field

- i. Fifty percent (50%) marks or its equivalent grade in case of candidates belonging to General / OBC / PWD / NRI / PIO / OCI categories
- ii. Forty five Percent (45%) marks or equivalent in case of candidates belonging to SC/ST categories.

### **b. Admission Test and Weightage**

- i. MNLU Aurangabad proposes to conduct a national level admission test with duration of two hours comprising 100 multiple choice questions on English, Economic & Business Environment, Numerical Ability & Arithmetic Reasoning and basic knowledge of Constitution and Law.

- ii. Based on merit at the admission test, the candidates will be short listed for personal interview. The final merit list will be prepared based on the following criteria:

### **c. Intake and Reservation Policy**

The total intake to the programme is 60 (sixty) students which include seats reserved under Maharashtra Reservation Policy.

**Note: Seat Distribution**

- i. The above seat distribution is based on the Section 6 (1) of the Maharashtra National Law University Act 2014 and Section 4 (2) of the Maharashtra State Public Services (Reservation for Scheduled Castes, Scheduled Tribes, De-notified Tribes (Vimukta Jatis), Nomadic Tribes, Special Backward Category and Other Backward Classes) Act 2001.
- ii. Maharashtra EWS seats have been calculated as per Maharashtra GO Raआधो-4019/ँ.N.31/16-अdated12.02.2019.
- iii. Non Creamy Layer certificate issued by the Govt. of

Maharashtra is mandatory for all the Maharashtra Reserved categories except-Scheduled Caste, Scheduled Tribe.

- iv. For MH-EWS, certificate in the prescribed format issued by the Competent Authority of Maharashtra Government is required.
- v. Caste Validity Certificate is required from the candidates admitted under caste based reservation.

**Note: Horizontal Reservations**

- i. 30% for Women across all categories.
- ii. 5% seats for Specially Abled Persons (SAP). Certificate of Disability issued by Department of Empowerment of Persons with Disabilities, Ministry of Social Justice & Empowerment, Govt. of India
- iii. Five (5)% seats of the total sanctioned intake for an institute, shall be reserved forwards of Ex-Servicemen/ Defence Personnel. Ex Servicemen / Defence Personnel Certificate from the respective department Unit/ Dept. / HQ/ Records/ RSWO/ZSWO/ Army/Navy/AirForce HQ is required.
- iv. 1% for Orphan (MH) candidates- Horizontally only in Unreserved Category.

**d. Programme is self financed in nature**

## Selection Procedure

### Stage 1: Online Registration

(i) Interested applicants who fulfill the afore-mentioned eligibility criteria will fill the registration form that aims at evaluating the applicant's proficiency in academics as well as in extra-curricular activities.

(ii) The eligible applicants will pay a non-refundable registration fee of Rs. 1000/- (One Thousand Only)

### Stage 2: Admission Test

(i) All the interested applicants will undergo MNLUA Common Admission Test that will examine the General English, Economic & Business Environment, Numerical Ability, Logical Reasoning and basic knowledge of Constitution and Law of the applicant.

**(ii) Admission Test 2023 to be conducted on June 25, 2023 from 9 AM onwards (Online mode).**

(iii) Admission Test will comprise of the following sections:

Economic & Business Environment	20
Basic Knowledge of Constitution and Law	10
Numerical Ability	15
Logical Reasoning	15
Verbal Abilities	25
Reading Comprehension	15
<b>Total</b>	<b>100</b>

**Note:** Each question will carry 2 marks. There will be a negative marking of 0.5 marks for each wrong answer. All the questions will be multiple-choice questions.



### **Stage III: Online Personal Interview (PI)**

- (i) The announcement of Call for Online Personal Interviews (PI) will be done in the last Week of June 2023. The shortlisting will be based on the Admission test 2023 scores.
- (ii) The candidates during their personal interviews will be judged on the basis of their academics, general awareness, and communication skills.
- (iii) The interviews are proposed to be held on July 1-2, 2023 (Tentative).

### **Stage IV: Announcement of Selection List and Offer**

#### **Acceptance**

- (i) The final Merit List will be generated based on the score of Personal Interview.
- (ii) The announcement of Merit/rank List and sending of Offer Letters to the selected candidates will be done by July 7, 2023. The candidates receiving the offer letter for MNLUA MBA (Financial Services and Court Administration) Admission 2023 and accepting the offer within the stipulated date will require to deposit the Offer Acceptance Amount (as mentioned in the offer letter) through an online payment link.

### **Stage V: Provisional Admission to two years MBA (Financial Services and Court Administration) programme (2023-25)**

The candidates accepting the offer of admission to two years MBA (Financial Services and Court Administration) programme (2023-25) will be given a confirmation letter. The candidate is required to pay the First Year Programme Fee (as mentioned in the confirmation letter) and needs to report to the institute campus for registration on the stipulated date.

#### **Hostel Allocation:**

MNLUA offers full time residential MBA (Financial Services and Court Administration) programme. Therefore, institute provides hostel rooms to the students on twin sharing basis.
