- 1. CRITERIA FOR REGISTRATION:** Those Candidates who have appeared for Common Law Admission Test-2022 (CLAT-2022) conducted by Consortium of National Law Universities, **can only Register** for the provisional admission as per the above mentioned matrix of vacancy of seats in the prescribed registration form.
- 2. REGISTRATION FORM:** Candidates should make an Application (Registration) only in the prescribed form i.e. Google Forms (**Link to the Google Form is:** <https://forms.gle/qHQ4nkrXyuvbKGha>). Any other format of Application will not be entertained.
- 3. EMAIL ID FOR REGISTRATION:** Candidates are hereby informed to use personal e-mail ID for the purpose of Registration and should use the same e-mail ID for all purposes till completion of Official Communications regarding Admission or Cancellation of Admission or Refund of Admission Fee.
- 4. REGISTRATION FEE:** Registration Fee (Processing Fee) for the Registration for the Vacant seats is **Rs.1000/-**. Candidates have to attach a receipt of payment of Registration Fee in the Google Form mentioned above. Candidates have to use the following link for making payments: <https://forms.eduqfix.com/irrlua/add> (**Note:** Registration Fee is not refundable)
- 5. SUBMISSION OF DOCUMENTS:** Candidates selected through vacant seats should be present in the University with the original documents on 03.09.2022.
- 6. SELECTION OF CANDIDATES:** Selection of Candidates against the vacant seats will be done on the basis of their **CLAT Ranking** in the respective Category. Candidates will be considered for admission against reserved categories if they have applied for the same in the CLAT application form.
- 7. DEADLINE FOR REGISTRATION:** The last date for the submission of Registration / Application Form (Google Form) shall be on or before **Wednesday, August 31, 2022 by 08:00 P.M.**
- 8. LIST OF SELECTED CANDIDATES:** List of the selected Candidates will be displayed on the website of the University (under Admission tab) on **Thursday, September 01, 2022**
- 9. PAYMENT OF ADMISSION FEE:** The selected candidates should pay the Admission Fee of the University before **Friday, September 02, 2022 by 5:00 p.m.** as per the details given on the website of the University.
